- **Product Name:** Ethyl 2,4-Decadienoate
- **Chemical Formula:** C₁₂H₂₀O₂
- **CAS No:** 37549-74-9
- **Synonyms:** Ethyl 2,4-decadienoate, pear ester
- **Recommended Use** Used as a flavoring agent with fruity, pear-like odor, also used in fragrances and flavor formulations.
