- **Product Name:** Theaspirane
- **Chemical Formula:** C₁₃H₂₂O

- **Synonyms:** Theaspirane, 2,6,10-Trimethyltrideca-2,6,10-triene-1,7-diol derivative
- **Recommended Use** Used as a fragrance and flavoring ingredient with tea-like, woody, herbal odor notes.
