Section 1: Product Identification

- **Product Name:** Geraniol-98
- **Chemical Formula:** C₁₀H₁₈O
- **CAS No:** 106-24-1
- **Synonyms:** *Trans*-3,7-Dimethyl-2,6-octadien-1-ol, Geraniol (purity ≥98%)
- **Recommended Use** Used as a fragrance ingredient in perfumery, cosmetics, and flavoring formulations with rose-like, sweet odor.
