#### Section 1: Product Identification

- **Product Name:** Cis-3-Hexenyl Acetate
- **Chemical Formula:** C<sub>8</sub>H<sub>14</sub>O<sub>2</sub>

- **Synonyms:** cis-3-Hexen-1-yl acetate; Leaf alcohol acetate
- **Recommended Use:** Used as a flavor and fragrance ingredient (green, fruity, apple/pear note) in foods, cosmetics, and perfumery.

## Section 4: First Aid Measures

- **Specific Hazards:** Flammable liquid and vapor (Flash point ~ 72 °C); emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.

- **Stability:** Stable under normal conditions.
