Section 1: Product Identification

- **Product Name:** 2-Pentylfuran
- **Chemical Formula:** C₉H₁₄O
- **CAS No:** 3777-69-3
- **Synonyms:** 2-Pentylfuran, 2-Amylfuran
- **Recommended Use** Used as a flavoring and fragrance ingredient, especially in roasted, green, and beany odor formulations.

Section 4: First Aid Measures

- **Appearance:** Colorless to pale yellow liquid
- **Odor:** Green, beany, roasted odor

- **Solubility:** Practically insoluble in water, soluble in ethanol and organic solvents

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
