Section 1: Product Identification

- **Product Name:** Cyclogalbanate
- **Chemical Formula:** C₁₁H₁₈O₃

- **Recommended Use:** Used as a fragrance ingredient in perfumery (green, balsamic, woody note).

Section 4: First Aid Measures
