Section 1: Product Identification

- **Product Name:** Decyl Anthranilate
- **Chemical Formula:** C₁₇H₂₇NO₂

- **Synonyms:** Anthranilic acid decyl ester; N-Decyl anthranilate
- **Recommended Use:** Used as a fragrance ingredient, UV filter in sunscreens, and cosmetic formulations.
