- **Product Name:** Beta-Ionone
- **Chemical Formula:** C₁₃H₂₀O
- **CAS No:** 79-77-6
- **Synonyms:** β-Ionone; 4-(2,6,6-Trimethyl-1-cyclohexen-1-yl)-3-buten-2-one
- **Recommended Use** Used as a fragrance ingredient in perfumes, cosmetics, soaps, and as a flavoring agent in foods and beverages.

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents, strong acids and bases.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
