- **Chemical Formula:** C₈H₁₄O₆

- **Synonyms:** L-(+)-Tartaric acid diethyl ester
- **Recommended Use** Used as a chiral reagent in organic synthesis, in the preparation of pharmaceuticals, and as a flavor and fragrance ingredient.
