- **Synonyms:** (-)-Isopulegol; Cyclohexanol, 5-methyl-2-(1-methylethenyl)-, (1R,2R,5R)-
- **Recommended Use** Used as a fragrance ingredient, flavoring agent, and an intermediate in the synthesis of menthol and other terpenes.

- **Concentration:** >95%
