Section 1: Product Identification

- **Product Name:** Estragole
- **Chemical Formula:** C₁₀H₁₂O

- **Synonyms:** Estragole; Methyl chavicol; 1-allyl-4-methoxybenzene
- **Recommended Use:** Used as a flavoring agent and fragrance ingredient in foods, beverages, and cosmetics.

Section 4: First Aid Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.
