Section 1: Product Identification

- **Product Name:** Ethyl Anthranilate
- **Chemical Formula:** C₉H₁₁NO₂
- **CAS No:** 87-25-2
- **Synonyms:** Anthranilic acid ethyl ester; Ethyl 2-aminobenzoate
- **Recommended Use:** Used as a flavoring agent (grape-like note), fragrance ingredient, and in cosmetics and pharmaceuticals.

- **Concentration:** 100%

Section 4: First Aid Measures

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

- **Stability:** Stable under normal conditions.
