Section 1: Product Identification

- **Product Name:** Iso Butyl Acetate
- **Chemical Formula:** C₆H₁₂O₂
- **CAS No:** 110-19-0
- **Synonyms:** Acetic acid isobutyl ester
- **Recommended Use** Used as an intermediate in organic synthesis and as a fragrance and flavoring ingredient with sweet, anisic odor notes.
