Section 1: Product Identification

- **Product Name:** Linalyl Acetate
- **Chemical Formula:** C₁₂H₂₀O₂
- **CAS No:** 115-95-7
- **Synonyms:** Acetic acid, linalyl ester
- **Recommended Use** Used as a fragrance ingredient in perfumes, cosmetics, and flavoring formulations with floral, lavender-like odor.
