Section 1: Product Identification

- **Product Name:** Isodecyl Acetate
- **Chemical Formula:** C₁₂H₂₄O₂
- **CAS No:** 69103-24-8
- **Synonyms:** Acetic acid, isodecyl ester
- **Recommended Use** Used as a fragrance ingredient in perfumery, cosmetics, personal care products, and as a flavoring agent.
