Section 1: Product Identification

- **Product Name:** Calamus Oil
- **Chemical Formula:** Mixture (sesquiterpenes, phenylpropanoids incl. β -asarone)
- **CAS No:** 8015-79-0
- **Synonyms:** Acorus calamus oil; Sweet flag oil
- **Recommended Use:** Used in perfumery, traditional medicine, and aromatherapy (restricted in food use due to β -asarone content).

Section 2: Hazards Identification

- **Classification (GHS):** Skin irritation (Category 2); Eye irritation (Category 2A); Carcinogenicity (Category 2, β -asarone component).

- Harmful if swallowed (due to β -asarone)
- Causes skin and eye irritation; may cause allergic reaction
- Combustible liquid (Flash point $\sim 93^{\circ}\text{C}$)
- Keep away from heat/sparks/open flames. No smoking
- Wear protective gloves/eye protection
- **IF ON SKIN or IN EYES:** Rinse cautiously with water; seek medical advice if irritation persists

Section 3: Composition / Information on Ingredients

- **Concentration:** 100%

Section 4: First Aid Measures

- **Inhalation:** Remove to fresh air. If symptoms develop, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical advice if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Remove contact lenses if present. Continue rinsing. Seek medical attention if irritation persists.
- **Ingestion:** Rinse mouth. Do NOT induce vomiting. Seek medical advice if feeling unwell.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide (CO₂); water spray.
- **Specific Hazards:** Combustible liquid (Flash point ~ 93 °C); emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use with adequate ventilation. Keep away from ignition sources.
- **Storage:** Keep container tightly closed. Store in a cool, dry, well-ventilated place away from heat and oxidizing agents.

- **Appearance:** Yellow to brown liquid
- **Odor:** Warm, woody, spicy odor
- **Boiling Point:** 250 °C (complex mixture)
- **Flash Point:** 93 °C (closed cup)
- **Solubility:** Insoluble in water; soluble in ethanol and oils
- **Molecular Weight:** Not applicable (complex mixture)

Section 10: Stability and Reactivity

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents.

- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
