Section 1: Product Identification

- **Product Name:** Carrot Seed Oil
- **Chemical Formula:** Mixture (mainly carotol, daucol, sesquiterpenes)
- **CAS No:** 8015-88-1
- **Synonyms:** Daucus carota oil; Carrot essential oil
- **Recommended Use:** Used as fragrance ingredient in perfumery, cosmetics, aromatherapy, and skincare formulations.

Section 4: First Aid Measures
