Section 1: Product Identification

- **Product Name:** Celery Seed Oil
- **Chemical Formula:** Mixture (mainly limonene, selinene, sedanolide, phthalides)
- **CAS No:** 8015-90-5
- **Synonyms:** Apium graveolens oil; Celery essential oil
- **Recommended Use:** Used as a flavoring agent, fragrance ingredient, and in aromatherapy.

Section 2: Hazards Identification

- **Classification (GHS):** Flammable liquid (Category 3); Skin irritation (Category 2); Eye irritation (Category 2A); Skin sensitization (Category 1).

- **Concentration:** 100%

Section 4: First Aid Measures

- **Suitable Extinguishing Media:** Dry chemical, foam, carbon dioxide (CO₂); water spray.
- **Specific Hazards:** Flammable liquid and vapor (Flash point ~ 58 °C); emits toxic fumes of carbon oxides under fire conditions.
- **Protective Equipment:** Firefighters should wear self-contained breathing apparatus and protective clothing.

Section 6: Accidental Release Measures

- **Personal Precautions:** Use personal protective equipment. Avoid breathing vapors. Ensure adequate ventilation. Eliminate ignition sources.
- **Environmental Precautions:** Prevent entry into drains and waterways.
- **Cleanup Methods:** Absorb with inert material (sand, earth). Collect in suitable container for disposal.

- **Handling:** Avoid inhalation of vapors and contact with skin/eyes. Use with adequate ventilation. Keep away from ignition sources.
- **Storage:** Keep container tightly closed. Store in a cool, dry, well-ventilated place away from heat and oxidizing agents.

- **Odor:** Warm, spicy, celery-like odor
- **Boiling Point:** 183 °C (complex mixture)
- **Flash Point:** 58 °C (closed cup)
- **Solubility:** Insoluble in water; soluble in ethanol and oils
- **Molecular Weight:** Not applicable (natural mixture)

Section 10: Stability and Reactivity

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
