Section 1: Product Identification

- **Product Name:** 4-Methyl Guaiacol
- **Chemical Formula:** C₈H₁₀O₂
- **CAS No:** 93-51-6
- **Synonyms:** Creosol; 4-Methyl-2-methoxyphenol
- **Recommended Use** Used as a flavor and fragrance ingredient (smoky, clove-like odor) and as an intermediate in organic synthesis.

- **Signal Word:** Warning

- **Concentration:** >95%

Section 4: First Aid Measures
