- **Product Name:** Cinnamyl Acetate
- **Chemical Formula:** C₁₁H₁₂O₂

- **Synonyms:** Acetic acid, 3-phenyl-2-propen-1-yl ester; Styryl acetate
- **Recommended Use:** Used as a fragrance and flavoring ingredient in perfumery, cosmetics, and foods.
