- **Product Name:** Carvyl Acetate
- **Chemical Formula:** C₁₂H₁₈O₂

- **Synonyms:** Acetic acid, carvyl ester; p-Mentha-6,8-dien-2-yl acetate
- **Recommended Use** Used as a fragrance and flavor ingredient in perfumery, food, and cosmetic applications.
