- **Product Name:** Cyclotene
- **Chemical Formula:** C₆H₈O₂
- **CAS No:** 80-71-7
- **Synonyms:** 2-Hydroxy-3-methyl-2-cyclopenten-1-one; Maple lactone
- **Recommended Use** Used as a flavoring and fragrance ingredient; imparts a sweet, maple-like aroma.
