- **Product Name:** Cis-3-Hexenyl Butyrate
- **Chemical Formula:** C₁₀H₁₈O₂

- **Synonyms:** cis-3-Hexen-1-yl butyrate; Leaf alcohol butyrate
- **Recommended Use:** Used as a flavor and fragrance ingredient (green, fruity note) in foods, cosmetics, and perfumery.

Section 4: First Aid Measures
