- **Product Name:** Cyclohexyl Salicylate
- **Chemical Formula:** $C_{13}H_{16}O_3$
- **CAS No:** 25485-88-5
- **Synonyms:** salicylic acid, cyclohexyl ester
- **Recommended Use** Used as an intermediate in organic synthesis and as a fragrance and flavoring ingredient with sweet, anisic odor notes.
