- **Product Name:** Methyl Hexanoate
- **Chemical Formula:** C₇H₁₄O₂
- **CAS No:** 106-70-7
- **Synonyms:** Hexanoic acid, methyl ester; Methyl caproate
- **Recommended Use** Used as a flavoring and fragrance ingredient; imparts fruity, pineapple-like odor.

- **Concentration:** >95%

Section 4: First Aid Measures
