Section 1: Product Identification

- **Product Name:** Octanal
- **Chemical Formula:** C₈H₁₆O

- **Synonyms:** n-Octanal; Caprylic aldehyde; Aldehyde C-8

- **Concentration:** >95%

Section 4: First Aid Measures

- **Suitable Extinguishing Media:** Water spray, foam, dry chemical, carbon dioxide (CO₂).
- **Specific Hazards:** Emits toxic fumes of carbon oxides under fire conditions.

- **Appearance:** Colorless to pale yellow liquid
- **Odor:** Citrus, fatty odor

- **Stability:** Stable under normal conditions.
