- **Product Name:** Thesaron
- **Chemical Formula:** C<sub>12</sub>H<sub>22</sub>O<sub>2</sub>
- **Synonyms:** Ethyl 2,2,6-trimethylcyclohexanecarboxylate, Norbornylmethyl acetate.
