- **Product Name:** Citronellol AJ
- **Chemical Formula:** C₁₀H₂₀O

- **Synonyms:** 3,7-Dimethyl-6-octen-1-ol, Elenol; β-Citronellol; Rhodinol
- **Recommended Use:** Used as a fragrance ingredient in perfumes, cosmetics, and household products. Imparts floral, rose-like, and citrus notes.
