- **Product Name:** Poivrol
- **Chemical Formula:** C₁₃H₂₀O
- **CAS No:** NA
- **Synonyms:** Peppery aldehyde; 2-Propylphenylacetaldehyde
- **Recommended Use:** Used as a fragrance ingredient in perfumes, soaps, and household products; imparts spicy, peppery, and woody notes.
