Section 4: First Aid Measures

- **Odor:** Strong, citrus, aldehydic, and waxy odor with orange peel and soapy notes; commonly used in floral and citrus perfumes.
- **Boiling Point:** 229.96 °C
- **Flash Point:** 81.8 °C (closed cup)
- **Solubility:** Insoluble in water; soluble in alcohol, ether, and fixed oils.

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents.
- **Hazardous Decomposition Products:** Carbon oxides under fire conditions.
