- **Product Name:** Isobutylmenthone
- **Chemical Formula:** C₁₃H₂₆O

- **Synonyms:** Isobutylmenthone; 2-Isobutyl-5-methylcyclohexanone
- **Recommended Use:** Used as a fragrance ingredient and flavoring agent; provides minty, camphoraceous, and woody notes in perfumery compositions..

- **Odor:** Minty, camphoraceous odor with woody undertones

- **Solubility:** Insoluble in water; soluble in alcohols, ether, and most organic solvents
- **Molecular Weight:** 198.35 g/mol

- **Stability:** Stable under normal conditions.
