- **Synonyms:** 3-Mercaptohexan-1-ol; Thiohexanole-3; 3-Thiohexanol
- **Recommended Use** Used as a flavor and fragrance ingredient in trace concentrations to impart tropical, fruity, and sulfur nuances. This MSDS covers the 5% diluted mixture.
