- **Synonyms:** 3-Thiohexyl acetate; Thiohexyl acetate; Acetic acid 3-thiohexyl ester
- **Recommended Use** Used as a flavor and fragrance ingredient in perfumery and food aroma applications, providing tropical, fruity, and sulfurous notes at low concentrations. This MSDS describes the 5% diluted form in triacetin.
