- **Odor:** Fresh, citrus, floral odor with light green and slightly rosy nuances

- **Solubility:** Insoluble in water; soluble in alcohol, ether, and most organic solvents.

- **Stability:** Stable under normal conditions.
- **Incompatible Materials:** Strong oxidizing agents.
