Section 1: Product Identification

- **Product Name:** Amberwood F
- **Chemical Formula:** C₁₅H₃₀O₂
- **CAS No:** Not Assigned
- **Synonyms:** Boisambrene Forte; Amberwood forte
- **Recommended Use** Used as a fragrance ingredient in fine perfumery and personal-care formulations, imparting warm woody-amber odor notes.

Section 2: Hazards Identification

- **Classification (GHS):** Skin Irritant (Category 2), Eye Irritant (Category 2A), Aquatic Chronic (Category 3).
- **Signal Word:** Warning
- **Hazard Statements:**

- Causes skin irritation
- Causes serious eye irritation
- Harmful to aquatic life with long lasting effects
- Causes serious eye irritation

• **Precautionary Statements:**

- Avoid contact with skin and eyes
- Wear protective gloves and eye protection

- **Concentration:** >95%

Section 4: First Aid Measures
