- **Product Name:** 2-Acetylthiazoline
- **Chemical Formula:** C₅H₇NOS
- **CAS No:** NA
- **Synonyms:** 2-Acetyl-2-thiazoline; corn thiazoline
- **Recommended Use** Used as a flavor and fragrance compound in food and aroma applications, imparting roasted, nutty, popcorn, and cereal-like notes.

- **Stability:** Stable under normal conditions.
