- **Product Name:** Isopropyl Cinnamate
- **Chemical Formula:** C₁₂H₁₄O₂
- **CAS No:** 7780-06-5
- **Synonyms:** Isopropyl cinnamate; 3-Phenyl-2-propenoic acid isopropyl ester; Cinnamic acid.
- **Recommended Use:** Used as a fragrance ingredient providing sweet, balsamic, and cinnamon-like notes; widely used in fine fragrances, cosmetics, and soaps.
