- **Product Name:** Benzaldehyde
- **Chemical Formula:** C₇H₆O

- **Synonyms:** Benzaldehyde; Benzenecarbaldehyde; Benzoic aldehyde; aromatic aldehyde used in flavor and fragrance applications; Norbornylmethyl acetate; Benzaldehyde
