- **Product Name:** Phenyl Ethyl Acetate

- **Synonyms:** 2-Phenylethyl acetate; Acetic acid phenethyl ester; Phenethyl acetate
- **Recommended Use** Used as a fragrance and flavor ingredient providing floral, rose, and honey-like odor notes.
