- **Product Name:** Rhodiarome
- **Chemical Formula:** C₉H₁₀O₃

- **Synonyms:** Ethylvanillin; 3-Ethoxy-4-hydroxybenzaldehyde
- **Recommended Use** Used as a flavor and fragrance ingredient providing creamy, sweet, vanilla-like odor notes.

- **Stability:** Stable under normal conditions.
