- **Product Name:** Romandolide
- **Chemical Formula:** C₁₅H₂₆O₄

- **Synonyms:** Musk methyl propionate; Acetic acid, (1-oxopropoxy)-, 1-(3,3-dimethylcyclohexyl)ethyl ester
- **Recommended Use** Used as a fragrance ingredient providing musky, floral, and powdery odor notes in fine perfumes and personal care products.
