Section 3: Composition / Information on Ingredients

- **Concentration:** 60% (as per commercial grade Geraniol 60)

Section 4: First Aid Measures

- **Inhalation:** Move to fresh air. If symptoms occur, seek medical attention.
- **Skin Contact:** Wash with plenty of soap and water. Remove contaminated clothing. Seek medical attention if irritation persists.
- **Eye Contact:** Rinse cautiously with water for several minutes. Seek immediate medical attention if irritation occurs.
- **Ingestion:** Rinse mouth. Do not induce vomiting. Seek immediate medical attention.

Section 5: Fire-Fighting Measures

- **Suitable Extinguishing Media:** Foam, dry chemical, carbon dioxide (CO₂), water spray.
- **Specific Hazards:** Vapors may form explosive mixtures with air. Emits carbon oxides under fire conditions.
